## Requirements

### Academic Requirements:

- Must meet academic grade requirements set by Principal.
- Must take the SRB Independent Study class with provided teacher.
- Must be a MHS Senior at the start of the 2019-20 school year.

### Credit Union Requirements:

- Attend interview with MCCU's Financial Education Coordinator and Teller Supervisor.
- Meet all employee requirements set by Marshall Community Credit Union.
- Comply with all MCCU polices.

## Safety and Security

During the training process, student representatives learn the importance of strict confidentiality. They are trained to protect members financial information and keep it private. The students use software that limits the amount of member information that is displayed to them. Plus, an MCCU team member is on-site at all times.

It is imperative that members personal and financial information is kept safe and secure. Sharing member information is strictly prohibited and will result in termination.

## Expectations

Student representatives are expected to not only abide by and follow all credit union rules, guidelines, policies and procedures, but as a part of the MHS SRB program, also

- Assist with setting goals (and working to help meet those goals),
- Participate in school events to help promote the SRB program,
- Complete monthly assignments,
- Actively participate in brainstorming sessions for new promotions,
- Help with advertising for the SRB, including marketing posters, weekly PA announcements, etc.
- Be available each Friday during lunch to work at the SRB,
- Be a positive credit union representative.

## Employment Opportunities

Chosen student representatives will be given part-time employment at Marshall Community Credit Union. Throughout the school year this employment opportunity is within MCCU's Teller Department where student representatives are encouraged to work as often as their schedule allows.
